

Val Jansante, representative of Congressman Smith introduced himself to the board and discussed different items that Congressman Smith is working on and concerns that the board may have.

John Webster, Murphy Tractor came to check in with the Board on District #3 Road Grader, to see if problems have been corrected.

Motion by Wonch seconded by Doyle to pass, approve and adopt Resolution #23-5 approving the County Board Chairman to sign the County Annual Certification of Program Compliance 2023. Yeas: Gaites, Doyle and Wonch.

Nays: None.

Motion by Gaites seconded by Wonch to pass, approve and adopt Resolution #23-6 determining a final levy allocation of General Fund: \$12,400 and Capital Fund: \$10,000.00 for a total of \$22,400 to the Logan County Agricultural Society. Yeas: Wonch & Gaites. Nays: Doyle.

Motion by Wonch seconded by Gaites to pass, approve and adopt Resolution #23-7 determining a final levy allocation of General Fund: \$49,000.00 and Sinking Fund: \$20,000.00 for a total of \$69,000 to the Stapleton Rural Fire District. Yeas: Gaites and Wonch. Nays: Doyle.

Motion by Doyle seconded by Wonch to pass, approve and adopt Resolution #23-8 reauthorizing the following Petty Cash Funds and list the amount to be carried by each Fund and dollar limit of an expenditure from each fund as follows: County General amount to carry in fund \$2,500.00 and dollar limit expenditure from this fund \$2,500.00, County Court amount to carry in fund \$55.00 and dollar limit of expenditure from fund \$55.00 and Veteran's Aid Fund amount to carry \$1000.00 and dollar limit expenditure from this fund \$1000.00. Yeas: Wonch, Doyle and Gaites. Nays: None.

Motion by Wonch seconded by Doyle to pass, approve and adopt Resolution #23-9 for an additional one percent increase to the base amount for restricted funds authority; for a total increase of three and one-half percent in the restricted funds authority for Fiscal year 2023-2024. Yeas: Doyle, Wonch and Gaites. Nays: None.

Reports were provided to the board by, Rich Cook, Highway and Weed Superintendent, Sean Carson, Sheriff and Emergency Manager, Andrew Van Velson, County Attorney and Cecil Wonch and Scott Gaites Commissioners.

The Hanich Trust Grant that was submitted to purchase a new motor grader was approved for \$150,000 and we should be receiving this amount by September 1.

Richard Gewecke, Treasurer gave a report.

A bid for additional concrete was submitted to the board from Roberts Sandoval Concrete in the amount of \$42,000 to finish putting concrete from building to street.


The Board of Equalization reviewed the ownership and use of all cemetery real property in Logan County and found them to qualify for the exemptions as of August 1, 2023.

The Board adjourned Board of Equalization at 10:31 a.m. and reconvened as Board of Commissioners.


