Regular meeting of the County Commissioners and Board of Equalization meeting of Logan County Nebraska was held in the Commissioners' Room of the Courthouse in Stapleton, Nebraska. Notice of these meetings were given in advance thereof by publication in The Stapleton Enterprise in the issue dated, June 12, 2025 and posting at least by the third day before the schedule meetings at the Logan County Courthouse and the Stapleton Post Office and was simultaneously given to the Chairman and all members of the County Board. Availability of the agenda was communicated in the notice and in the notice to members of the Board of this meeting. All proceedings hereafter shown were taken while the convened meetings were open to the attendance of the public. Agenda posted and open meetings poster is on wall in Commissioners Room.

Meeting was called to order by Chairman, Lee Wonch.

Scott Salisbury with the Logan County Ag Society addressed the board on a special designated license for Logan County Fair & Rodeo beginning on August 1, 2025 at 6:00 pm through August 2, 2025 at 12:00 am. Motion by Kramer seconded by Hill to approve the special designated liquor license for Logan County Fair & Rodeo. Yeas: Kramer and Hill. Nays: Wonch.

Reports were given by Richard Cook, Highway Superintendent and Weed Supervisor;

Ryan Dickinson from Dickinson Land Surveyors Inc met with the board to discuss a project for Custer Public Power District. Dickinson estimated the cost to the county would be \$3000.00 to restore lost corners. Motion by Kramer seconded by Hill to agree to have Dickinson set lost corners. Yeas: Wonch, Kramer and Hill. Nays: None

Richard Cook, Highway Superintendent presented the board with a road study of County Road 72, located on the section line between Section 9 Township 17 Range 26 and Section 16 Township 17 Range 26. No action taken on road study for County Road 72, Highway Superintendent will update for July meeting.

Kylee Joyce, representative for Region II, addressed the board on Region II services for the last year.

Sean Carson, Sheriff gave a sheriff report. The Sheriff also requested to surplus from the Sheriff's office the following items: 300 blackout complete upper Aero Precision model gun and a Vortex Strike Eagle Scope. Yeas: Hill, Kramer and Wonch. Nays: None

Richard Gewecke, Treasurer gave a report and Board Members gave reports on various meetings.

Motion by Kramer seconded by Hill to approve Audit Report for the 2023-2024 budget year. Yeas: Wonch, Hill and Kramer. Nays: None.

The board reviewed the budget balances for the 2024-2025 budget year.

Motion by Kramer seconded by Hill to reappoint Justin Rahn to the Veteran Service Board for another 5 years starting June 1, 2025 through May 31, 2030. Yeas: Kramer, Hill and Wonch. Nays: None.

Debbie Myers turned in her resignation letter because she is retiring on July 11, 2025. Motion by Hill seconded by Kramer to accept Debbie Myers resignation. Yeas: Wonch, Kramer and Hill. Nays: None.

County trucks and tractor were discussed, tabled until next meeting.

Wind turbines and solar farms were discussed and a motion was made by Hill seconded by Kramer to put a moratorium to not let any wind turbines or solar farms be put into Logan County until new zoning regulations are completed. Yeas: Wonch, Kramer and Hill. Nays: None.

Richard Cook presented the board with Veteran Service Interlocal agreements with Thomas County for 2025-2026 year at a cost to Thomas County of \$7000 and with McPherson County for 2025-2026 year at a cost to McPherson County of \$1700. Motion by Kramer seconded by Hill to accept the Interlocal agreements for Thomas and McPherson Counties for the 2025-2026 year. Yeas: Hill, Kramer and Wonch. Nays: None.

The Board adjourned regular meeting at 10:15 a.m. to resolve itself to meet as a Board of Equalization. Chairman, Lee Wonch called the Board of Equalization meeting to order present were: Lee Wonch, Chairman, Jon Hill, Board Member, Nathan Kramer, Board Member and Debbie Myers, Clerk/ Assessor.

The Logan County Assessor presented the board with her 3-year plan for review.

The Commissioners will meet again as the Board of Equalization on July 9, 2025 at 9:00 A.M. to hear protests.

Board of Equalization adjourned at 10:20 a.m.

No further business meeting adjourned to meet July 9, 2025 at 9:00 a.m. to hear protests and July 16, 2025 for regular meeting.
