

COUNTY COMMISSIONERS' PROCEEDINGS

Regular meeting of the County Commissioners of Logan County, Nebraska was held in the Commissioners' Room of the Courthouse in Stapleton, Nebraska. Notice of this meeting was given in advance thereof by publication in The Stapleton Enterprise in the issue dated January 15, 2026, and posting at least by the third day before the scheduled meeting at the Logan County Courthouse and the Stapleton Post Office and was simultaneously given to the Chairman all members of the County Board. Availability of the agenda was communicated in the notice and in the notice to members of the Board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. Agenda posted and open meetings poster is on wall in Commissioners Room.

Meeting was called to order by Chairman Lee Wonch. Roll call was answered as follows: Present: Lee Wonch, Chairman, Nathan Kramer, Board Member, and Jon Hill, Board Member. Also present were Jennifer Nicholson, Clerk/Assessor, Andrew Van Velson, County Attorney, Richard Gewecke, Treasurer, Richard Cook, Highway and Weed Superintendent, and Sean Carson, Sheriff and Emergency Manager, Dan Kramer, and Bryan Higgins.

Motion by Kramer seconded by Hill to approve December 16, 2025, minutes without reading, as the Clerk had previously furnished each member with a copy thereof. Yeas: Kramer, Hill, and Wonch. Nays: None.

Motion by Kramer seconded by Hill to reappoint Lee Wonch Chairman for 2026. Yeas: Kramer, Hill, and Wonch. Nays: None. Chairman Wonch continued the meeting.

Motion by Wonch seconded by Hill to reappoint Nathan Kramer Vice Chairman for 2026. Yeas: Wonch, Hill, and Kramer. Nays: None.

Clerk informed the board that County Board Chair Workshop is on February 13, 2026, and West Central District Meeting is March 26, 2026.

Dan Kramer and Bryan Higgins from the Veterans Service Board requested the board raise Veteran Service Officer Richard Cook's wages. Motion by Hill seconded by Kramer to raise Cook's hourly wage to \$18.00 per hour. Yeas: Hill, Kramer, and Wonch. Nays: None. The Veterans Service Board also spoke to the board about Governor Pillen's proposed transfer of \$2.5 million from the Nebraska Veteran's Aid Fund to help balance the state budget. They requested the Commissioners join in the objections as these funds are used to help struggling Veterans. The Commissioners agreed to draw up and sign a letter protesting the transfer.

Motion by Hill seconded by Kramer for salaries for the appointed officers and rates to be set as follows: Emergency Manager \$18.00 per hour, Highway Superintendent \$18.00 per hour, Noxious Weed Superintendent \$18.00 per hour, and County Surveyor at \$1.00 per annum. Rates for occasional employment for equipment operators are \$17.00 per hour and machine hire and operator \$200.00 per hour. Rates for copies are \$0.25 per copy, emailed copies \$1.50 per copy and faxed copies \$2.50 for first page and \$1.00 for each additional page. Mileage rates are set by the State at .725 cents per mile. Yeas: Hill, Kramer, and Wonch. Nays: None.

The 2026 annual salary for County Clerk, Treasurer, and Sheriff were previously set at \$54,795 and County Commissioners at \$9,322.

Hearing of the One- and Six-Year Road Plan was opened at 9:30 am. Motion by Hill seconded by Kramer to pass, approve, and adopt Resolution #26-1 approving the One-and Six-Year Road Plan as presented. Yeas: Wonch, Kramer, and Hill. Nays: None. Hearing concluded at 9:39 am.

Richard Cook, Highway and Weed Superintendent, Andrew Van Velson, Attorney, Sean Carson, Sheriff and Emergency Manager, and Richard Gewecke, Treasurer gave monthly reports.

Motion by Hill seconded by Kramer to designate The Stapleton Enterprise as the official newspaper and the Logan County Website, logancounty.ne.gov, as the official website of Logan County. Yeas: Hill, Kramer, and Wonch. Nays: None.

Motion by Hill seconded by Kramer to set the date for the regular meeting of Logan County to be the third Wednesday of the month at 9:00 a.m. Yeas: Wonch, Kramer, and Hill. Nays: None.

Motion by Kramer seconded by Hill to designate the Courthouse, Post Office, Frey's General Store, Kimber's, Stapleton Cooperative Market, The Feed Bunk, Creative Printers and the Logan County Website as possible places to post notice of a meeting when it is necessary to hold an emergency meeting without reasonable notice. Yeas: Kramer, Hill, and Wonch. Nays: None.

Richard Gewecke, Logan County Treasurer, made semi-annual settlement with the County Board and filed a statement showing the amount of money on hand belonging to the various funds. The County Board examined such settlement and found same to be correct and hereby entered and order to that effect. Motion by Hill seconded by Kramer to approve the semi-annual statement. Yeas: Hill, Kramer, and Wonch. Nays: None.

Road men wages were discussed. Motion by Kramer seconded by Hill to raise the road maintenance men from \$22.00 per hour to \$23.00 per hour. Yeas: Hill, Kramer and Wonch. Nays: None.

Richard Cook, Noxious Weed Superintendent, presented the board with the annual weed report. Motion by Kramer seconded by Hill to accept the report as written and to have Chairman Wonch sign. Yeas: Kramer, Hill, and Wonch. Nays: None.

Annual signature report was signed by the County Officials and their Deputies


No further business, meeting adjourned at 10:36 a.m.
